# DATA PROTECTION NOTICE

#### Your personal data – what is it?

The processing of personal data is governed by the General Data Protection Regulation 2016/679 (the "GDPR"). Personal data relates to a living individual who can be identified from that data. Identification can be by the information alone or in conjunction with any other information in the 'data controller's' (see below) possession or likely to come into their possession.

#### Who is the data controller?

The PCC of St Mary's Watford is the data controller. This means it decides how your personal data is processed and for what purposes. The PCC's contact details are below.

#### How do we process your personal data?

The PCC of St Mary's Watford complies with its obligations under the GDPR by keeping personal data up to date; by storing and destroying it securely; by not collecting or retaining data that is not required for its stated purposes; by protecting personal data from loss, misuse, unauthorised access and disclosure and by ensuring that appropriate technical measures are in place to protect personal data.

We use your personal data for the following purposes:

- To enable us to provide a voluntary service for the benefit of the public in a particular geographical area as specified in our constitution;
- To administer membership records;
- To fundraise and promote the interests of the PCC;
- To manage our employees and volunteers;
- To maintain our own accounts and records including the processing of Gift Aid applications.

#### What is the legal basis for processing your personal data?

- Explicit consent of the data subjects (i.e. you) so that we can keep you informed about news, events, actives and services and process your Gift Aid donations.
- For carrying out obligations under employment, social security or social protection legislation, or a collective agreement.
- Legitimate interests: processing is carried out in accordance with our religious aims provided that the processing relates only to present or former members or supporters, and there is no disclosure to a third party without consent.

#### Sharing your personal data

Your personal data will be treated as strictly confidential and we will only share your data with third parties outside of the parish with your consent.



## How long do we keep your personal data?

We keep your personal data for no longer than reasonably necessary and in accordance with the guidance set out in the guide "Keep or Bin: Care of your parish records" a copy of which is available from the Church of England website.

Specifically, we retain Electoral Roll data while it is still current; Gift Aid declarations and associated paperwork for up to 7 years after the tax year to which they relate; and Parish Registers (baptisms, marriages, funerals) permanently.

## Your rights and your personal data

Unless subject to an exemption under the GDPR, you have the following rights with respect to your personal data: -

- The right to request a copy of your personal data which the PCC of St Mary's Watford holds about you;
- The right to request that the PCC of St Marys Watford corrects any personal data if it is found to be inaccurate or out of date;
- The right to request your personal data be erased where it is no longer necessary for the PCC of St Mary's Watford to retain such data;
- The right to withdraw your consent to the processing of your personal data at any time;
- The right, where there is a dispute in relation to the accuracy or processing of your personal data, to request a restriction be placed on further processing;
- The right to lodge a complaint with the Information Commissioner's Office.


# **Further processing**

If we wish to use your personal data for a new purpose, not covered by this Data Protection Notice, then we will provide you with a new notice setting out the relevant purposes and processing conditions and explaining this new use prior to commencing the processing. Where and whenever necessary, we will seek your prior consent to the new processing.




## Date of next review
